## VinaCapital Ventures joins Sygnum's Series B funding round

The Series B funding round raised USD90 million and values the company at approximately USD800 million. The amount of VinaCapital Ventures' investment was not disclosed.

Sygnum stated that it intends to use the proceeds of this round to accelerate the development of new offerings and expand into new global markets.
