

ETF Overview

VinaCapital VN100 ETF is an Exchange Traded Fund that seeks to replicate the performance of the VN100 index.

The VN100 Index is a free-float adjusted market capitalization weighted index which measures the performance of the 100 largest and most liquid stocks listed on the Ho Chi Minh City Stock Exchange (HOSE).

Why VN100 ETF?

Closer performance to the VN-Index. Exposure to large and mid-cap Vietnamese companies.

Approximately exposure to 85% of VN-Index. Not subject to foreign ownership limit.

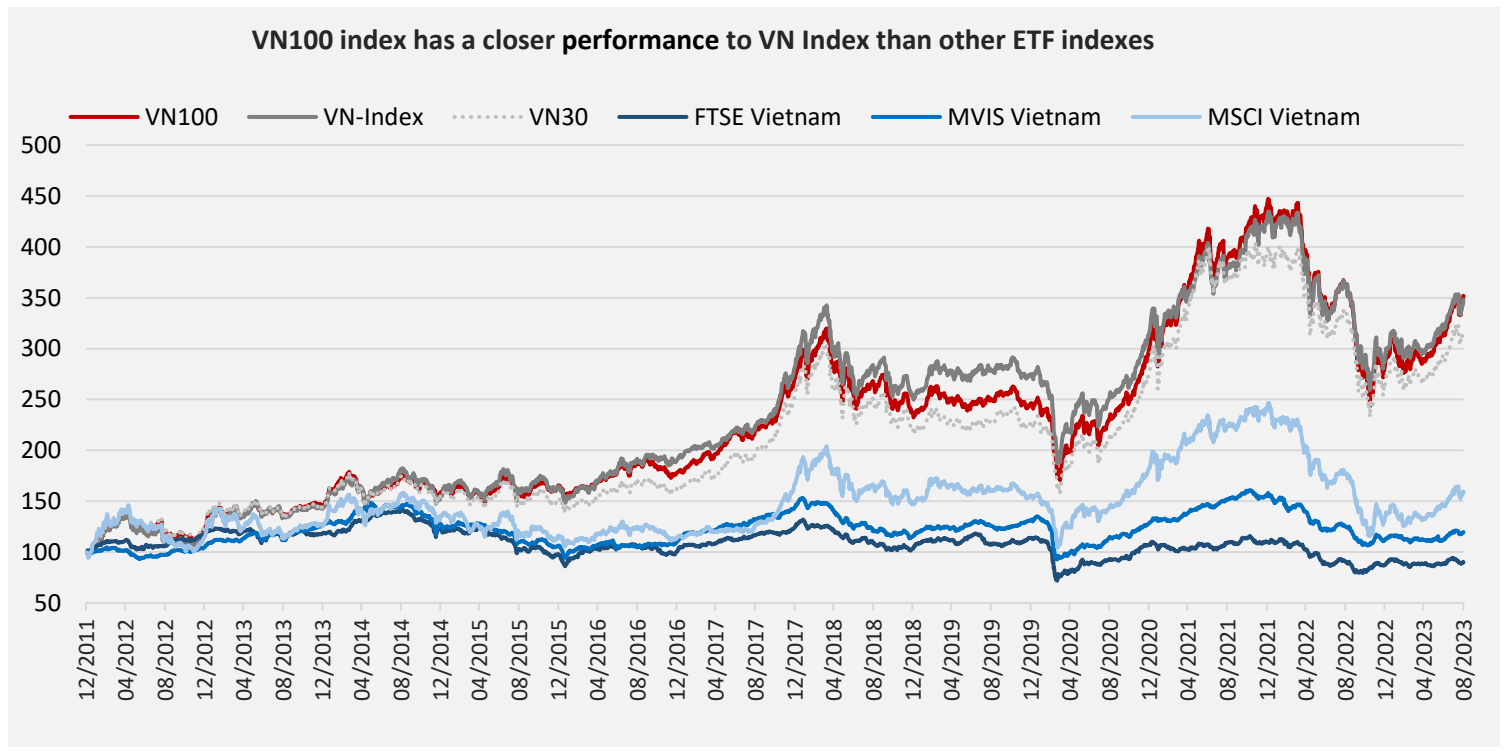
VinaCapital VN100 ETF objective

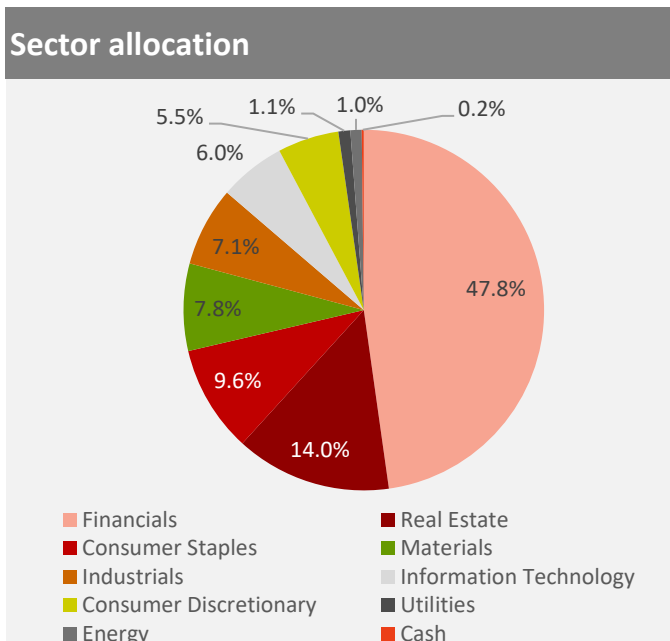
Track and replicate 95% of the VN100 Index. Target a tracking error of 0.5%.

The ETF will be rebalanced quarterly. Tracking error will be calculated weekly.

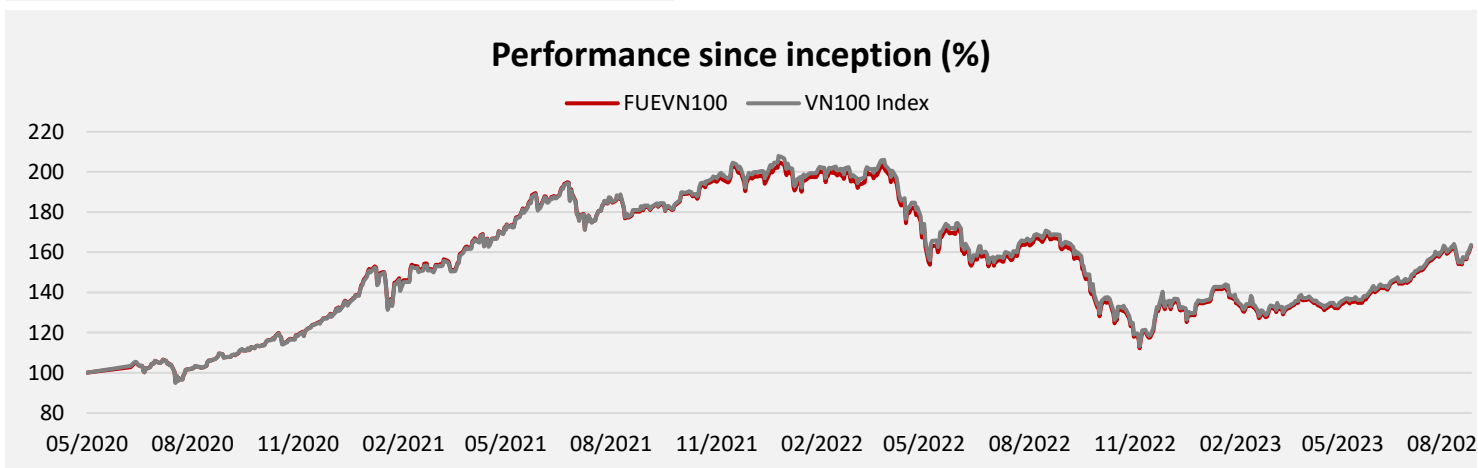
